



On October 1, 2023, port traffic control operations* for the Osaka Ku, Sakai- Semboku Ku, and Kobe Ku of Hanshin Port will be integrated into the Osaka Wan Vessel Traffic Service Center.

After this integration, please refer to the reverse side of this leaflet for route information and advance information.

*Traffic signals are used to control vessel traffic in narrow waterways and waterways where vessels pass frequently within the port areas.



Application: February 1, 2024 onward

Vessels navigating the northern waters of Osaka Bay will be required to listen in on VHF radio telephone for information provided by the Osaka Wan Vessel Traffic Service Center.

Vessels with a length of 50 meters or more in waters covered by the Maritime Traffic Safety Act


Vessels with a gross tonnage of more than 500 tons in waters subject to the Port Regulations Act

Provision of information, etc.

The OSAKA WAN Vessel Traffic Service Center will provide information to support the safe navigation of vessels in waters where the vessels are obliged to listen in for information and in the surrounding waters.

Please listen to VHF radiotelephone CH16 when navigating in waters where the vessels are obliged to listen in for information.

Obligation to listen in for information (at all times)



Pre-Entry Report (based on the Maritime Traffic Safety Act and Port Regulations Act)

Notification reception hours will change from October 1, 2023. Reception period: From 8:30 am four days prior until noon of the day prior to the scheduled date of entry

- In accordance with the provisions of the Maritime Traffic Safety Act, when a huge vessel intends to sail a route, it must notify the Commandant of the Japan Coast Guard (Director of the Vessel Traffic Service Center) in advance of the scheduled time of navigation of the route.
- In accordance with the provisions of the Port Regulations Act, when a vessel with a gross tonnage or length which meets or exceeds those specified by ministerial ordinance intends to sail on a waterway, it is necessary to notify the port master (via the Director of the Vessel Traffic Service Center) in advance of the scheduled time of navigation of the waterway.



Application: October 1, 2023 onward

VHF Radio Telephone Reporting

Application: October 1, 2023 onward

The VHF radio telephone call name used for notifications based on the Maritime Traffic Safety Act and the Port Regulations Act will be unified as "Osaka MARTIS".

*Information will be provided by VHF radio telephone in Hanshin Port Osaka Ku and Sakai-Semboku Ku under the call name "Osaka Harbor Radar" until September 30, 2023. Channels (CH) on VHF radio telephone used by us at OSAKA WAN Vessel Traffic Service Center

16CH: Calling & Replying 13CH: Calling & Communicating 14CH & 66CH: Communicating

- * When making pre-entry report under the Port Regulations Act in conjunction with the pre-entry report in accordance with the Maritime Traffic Safety Act, please add the name of the mooring facility in the port and the scheduled time of arrival in the controlled waterway, or use the above shared (downloadable) form for reporting by e-mail.
- * If you wish to report in writing, please bring it to or submit it by post to the OSAKA WAN Vessel Traffic Service Center.
